The following discussions/suggestions are posed by the respective members.


- Members suggested to give equal weightage to all the course outcomes in Mid Term examinations.

Subject Moderation: Moderation can be given, if the percentage of pass in the external exam of a subject is less than 50%. Marks may be added to all the candidates who appeared for that subject and secured at least one mark, as per the norms, given in the following Table-1.

Marks to be added, if the pass % in the External Maximum Marks in Examination of a particular subject is **External Examination** 30 % and less above 30% & below 50% 2 3 ≤ 60 3 4 60 to 80 80 to 100 5 4 5 >100 6

Table-1: Subject Moderation

Adjustment/Grafting of Marks: Even after applying subject moderation, if a student fails in one or more subjects but secures not less than 75% of required maximum marks in the end examination in those subjects. Moderation will be consideration to an extent of 1% of marks secured in all passed subjects of that examination subjected to a maximum limit given in the Table-2.

Revaluation, Recounting: After declaration of results, a student who seeks the revaluation of the answer script, the student can register for the revaluation with prescribed fee. The controller of examinations shall arrange for the revaluation and after approval from JNTUH, declares the results. Revaluation is not permitted to the courses other than theory courses.

- Revaluation is applicable only for external theory subjects. If the difference between previously awarded marks and revaluation marks is less than 15% of external maximum marks, in such case there will be NO CHANGE in the previously awarded marks. However, if the difference between previously awarded marks and revaluation marks is more than 15% marks, in such case, marks awarded in revaluation will be consider as FINAL MARKS.
- Revaluation is not applicable for internal examinations
- Revaluation is not applicable for laboratory courses
- Revaluation is not applicable for mandatory courses
- Revaluation is not applicable for project work

If any student applies for the recounting of the subject appeared in the semester end examination, his/her awarded marks in the answer script will be recounted once again. If any change in the marks compared to initial awarded marks will be declared after approval from the university.
