3.2 Consideration and approval of ECE/EEE faculty in B.Tech- CSE department

As per the guidelines of the affiliating university, the affiliating colleges are permitted to engage faculty with specialisation in interdisciplinary branches not exceeding the 10% of the total faculty strength in the discipline concerned vide Cir.No. UAAC/Faculty/Eligibility/2021, dated: 27-07-2021.

Few faculty members from ECE/EEE have completed two NPTEL MOOC courses offered by the department of Computer Science and Engineering of various IITs and other prestigious institutes. As per the guidelines of JNTUH, the faculty of ECE/EEE with M.Tech / Ph.D with two NPTEL courses in CSE are eligible for consideration of SCM in B.Tech-CSE against 10% of faculty positions.

Resolution: The board noted the details and suggested to follow the guidelines of the university. The board permitted to shift these faculties to B.Tech-CSE and recruit additional faculty in their parent department in place of these faculty as per the rules of statutory bodies.
