**PREAMBLE**

Where as, Narsimha Reddy Engineering College, a premier technical institution was founded by a notable academician with magnificent mission and noble vision Sri. J.Narasimha Reddy in the year 2007. The college is approved by All India Council for technical Education (AICTE) affiliated to JNTU Hyderabad and functions as a private self-financing institution under the patronage of Jakkula educational society. The college offers five UG programs in B.Tech. Viz., CE, EEE, ME, ECE & CSE and PG programs like M.Tech and MBA.

Where as **NRCM** has approached "**CADDPRO Organisation**" for establishing a co-operative program in training research and industry oriented laboratory establishment and support between **NRCM** and "**CADDPRO Organisation**".

Now therefore **NRCM** and "**CADDPRO Organisation**" here by agree to introduce a co-operative training program in research areas and industry oriented laboratory establishment and support to be mutually decided by both the parties. The intention of the parties to this agreement for **CIVIL Engineering, MECHANICAL Engineering & Electrical & Electronics Engineering** is that the program will compliment each other's strengths and will benefit both the parties. While "**CADDPRO Organisation**" will provide necessary facilities and guidance to the under graduate/Post Graduate students of the **NRCM** for the conduct of academic studies and research, the **NRCM** will recognize "**CADDPRO Organisation**" as a research center for the **NRCM**.

### **1. Scope of the MOU:**

This MOU contains the modalities, terms and condition for the co-operative program in academic training, placements and research in the areas of mutually decided by both the parties.

### **2. Responsibilities of "CADDPRO Organisation" agrees**

1. CADDPRO Organisation "may establish Research and Development cell with in the campus and encourage NRCM to establish industry relations.
2. "CADDPRO Organisation" may arrange Training programs on Advances in Technology with nominal charges in college premises(NRCM).
1. " CADDPRO Organisation" may arrange summer/winter internships for sponsored registrants from NRCM
2. Supporting in Internship and training for B.Tech & M.Tech, the Internship work can be submitted as final year university projects.
3. CADDPRO Organization will support to Research and industry oriented laboratory establishment.

This list would be expended by the mutual agreement between the parties to the MOU.

Now therefore in consideration of the rights and obligations herein set forth, parties agree as follows:

### **4. Responsibilities of NRCM agrees**

1. To nominate one senior faculty member each in the identified areas to co-ordinate the co-operation program from both sides.
2. Experts from "CADDPRO Organisation" acceptable to as and when required by the NRCM would be included in the relevant board of studies of the NRCM (depending upon experts availability), to recommend/provide the students for the placement organized by the "Company Name for NRCM students.
3. NRCM will recommend students and faculty to carry out the training at "Narasimha reddy engineering college "with concessional fee agreed by "CADDPRO Organisation" for NRCM students

4. NRCM hereby agrees to keep all the received proprietary information of "CADDPRO Organisation" confidential and will not divulge/transfer it to third party at any cost.

#### 5. Reviews

NRCM and "CADDPRO Organisation" will periodically review the program and make necessary changes as and when required.

#### 6. Intellectual Property Rights

If any Intellectual Property right (IPR) arises from NRCM, it will be owned by NRCM. If any IPR arises from "CADDPRO Organisation", it will be owned by "CADDPRO Organisation". The benefits of IPR can be shared as and when needed by both the parties.

#### 7. Duration and Termination

1. This MOU shall be effective from the date it is signed and shall be valid for five years. This MOU shall be subject to extension by mutual consent.

2. If either party commits any service breach of its obligation and fails within 30 days of written notice to remedy the same, the other party may forth with by notice in writing to terminate this MOU.

3. No extension, alteration modification or additions to this MOU, or any waiver of any of the terms here of shall be valid unless made in writing and signed by the authorized representatives of the respect Parties. The signatures below indicate that the parties have agreed to all the terms and conditions of this MOU.
